 - Library employees retiring under the Wisconsin Retirement Fund standards will have a full (100%) conversion of their accumulated sick leave-maximum of one hundred fifty days--paid out at the rate of retirement into a post-retirement fund health account at the time of retirement. As per Village accounting standards, a separate line item will be maintained in the library budget to account for this benefit.

• Resolution language: NOW, THEREFORE, BE IT RESOLVED, that the Library Board formally adopts the following benefit policy to include the creation of sick leave accrual with a cap higher than those provided to non-Library Village employees as well as post-retirement fund health account at the time of retirement as outlined below.

302 Sick Leave

- Library Employees eligible for benefits earn sick leave at the same rate as other village employees to a maximum of one thousand two hundred (1,200) hours by each regular full-time employee.
- Library employees retiring under the Wisconsin Retirement Fund standards will have the option of a full (100%) conversion of their accumulated sick leave. A maximum of one hundred fifty days--may be paid out at the rate of retirement into a post-retirement fund health account at the time of retirement, with the remainder of their sick leave hours cashed out at 100%. As per Village accounting standards, a separate line item will be maintained in the library budget to account for this benefit.
