- 1. Call to order
 - Linda called the meeting to order at 7:00 p.m.
- 2. Name substitute secretary for this meeting
 - Schuetz motioned to nominate Updike as the secretary for this meeting, Linda seconded
 - Motion carried
- 3. Roll call of members
 - Schuetz, Updike, Scott, Colby, present with Shaffer
 - Members of the public: Joe Block, Scott Patchin, Jeannie (from village office), Gary Olson and Pat Mommaerts and Lisa Lutz
- 4. Proof of posting
 - Colby read the proof of posting
- 5. Adoption/amendment of agenda
 - Schuetz motioned to adopt the agenda amended to include public comment.
 - Scott seconded the motion
 - Motion passed
- 6. Reading and approval of minutes
 - Updike motioned to approve the minutes, with the correction noted of changing her to Shaffer
 - Schuetz seconded
